Researcher with substantial experience evaluating criminal justice programs, policies, reforms, and systems, as well as programs and policies targeted to noncustodial parents and disadvantaged young people. Current responsibilities include project management and direction, research design, impact analysis, interview and focus group facilitation, policy brief and report writing, presentation of research findings, and project development, with vast prior experience in data acquisition, processing, analysis, and management.

Current projects include (1) the Pretrial Justice Collaborative, a study of pretrial practices in eight jurisdictions across the country aimed at building usable evidence on the most effective strategies for reducing pretrial detention, minimizing supervision conditions, and reducing racial and economic inequities while preserving court appearance; and (2) the Procedural Justice-Informed Alternatives to Contempt Demonstration, a random assignment study testing the efficacy of incorporating procedural justice principles into child support practices to re-engage noncustodial parents who have fallen behind in their payments rather than relying on a court-led civil contempt process.

Selected past projects include the process and impact evaluation of New York City's Supervised Release program, a bail alternative intended to reduce the use of pretrial detention and money bail while ensuring defendants' appearance in court and maintaining public safety; the Enhanced Transitional Jobs Demonstration, for which Skemer served as lead researcher for The Doe Fund's New York City-based Pathways reentry program, whose services were targeted to the formerly incarcerated; the Subsidized and Transitional Employment Demonstration, a random assignment study testing innovative training and subsidized employment strategies with various populations that struggle in the labor market, including disconnected young people, noncustodial parents, and TANF (Temporary Assistance for Needy Families) recipients; the Evaluation of the PACE Center for Girls, a school-based, gender-responsive program offering both academic and social services to at-risk middle and high school-age girls in Florida, many of whom interact with the juvenile justice system; and the Youth Villages Transitional Living Evaluation, an intensive

counseling and support program that serves former foster care and juvenile justice youth in Tennessee.

With over 10 years of experience in research and evaluation across a wide range of projects and content areas, Skemer is adept at collaborating with a broad array of system actors and stakeholders to implement research designs ranging from randomized controlled trials to quasi-experimental methods to descriptive analyses, all in the service of producing clear, reliable, actionable research evidence for policymakers and practitioners.
